


Instructions for Visa C application




- 1) Visa C application can be submitted via <https://evisa.welcometosrbia.gov.rs/> with the obligation for the user to register first.


Available services

A short-stay visa C is a permit issued to a foreigner for entry, transit and short-term stay on the territory of the Republic of Serbia for up to 90 days.

Under full responsible publication that the stated data are true and entered correctly, as well as that the attached documentation is valid. I agree that my personal data may be processed and that field checks and checks of all data being of importance in procedure of temporary residence approval may be performed. I agree to actively trace email and status under submitted request and promptly download the sent documentation and procedures according to the same. Date of document delivery is considered the date when the competent authority sent the notification by name. I am aware that due to incomplete and inaccurate data the request may be denied / rejected. This statement is irrevocable and the beginning of giving this consent entered data may not be changed.

All payments will be made in the local currency of the Republic of Serbia - dinar (RSD). For informative display of prices in other currencies, the exchange rate is used middle exchange rate of the National Bank of Serbia. The amount for which your payment card will be charged will be expressed in your local currency through conversion to the same at the exchange rate used by the card organizations, which cannot be known to us at the time of the transaction. 10) The fee for visa C is €90 in RSD equivalent at the middle exchange rate of the National Bank of Serbia.

Note: Users who choose China, Armenia, Mali, Pakistan or Syria as their passport issuing country are exempt from fee payment.
