


Instructions for Visa D application




- 1) Visa D application can be submitted via <https://evisa.welcometosrbia.gov.rs/> with the obligation for the user to register first.

Visa C

A short-stay visa C is a permit issued to a foreigner for entry, transit and short-term stay on the territory of the Republic of Serbia for up to 90 days.

Visa D

Visa D for a long stay is a permit issued to a foreigner for entry and stay, and work in case when the visa is issued on the basis of employment, in the territory of the Republic of Serbia for a period of 90 to 180 days.

5) In this step, enter personal data, family data and employment data. After entering the information, proceed to "Next step".

6) After entering the information on the travel documents, proceed to "Next step".

Note: The travel document must be valid for another 3 months after the desired stay.

7) In the fourth step, enter data on the visa for which you are applying, data on the previous stay in the Republic of Serbia and data on the intended (future) stay in the Republic of Serbia.

All payments will be made in the local currency of the Republic of Serbia - dinar (RSD). For informative display of prices in other currencies, the exchange rate is used middle exchange rate of the National Bank of Serbia. The amount for which your payment card will be charged will be expressed in your local currency through conversion to the same at the exchange rate used by the card organizations, which cannot be known to us at the time of the transaction. As a result of this conversion there is a possibility of a slight difference from the original price listed on our website. Thank you for your understanding.

10) The fee for visa D is €50 in RSD equivalent at the middle exchange rate of the National Bank of Serbia.

Note: Users who choose China, Armenia, Mali, Pakistan or Syria as their passport issuing country are exempt from fee payment.
